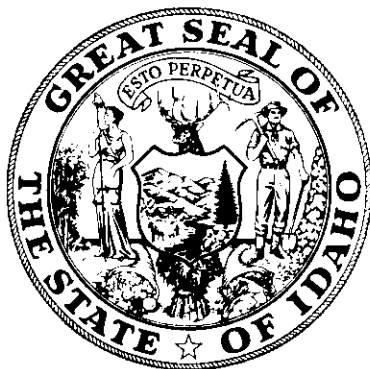

ARTICLES OF INCORPORATION
OF
POTLATCH SUPPLIES, INC.

KNOW ALL MEN BY THESE PRESENTS that the undersigned Calvin Raugust as President and agent of POTLATCH SUPPLIES, INC., hereby proposes to form a corporation under the laws of the State of Idaho and in pursuance thereof does hereby sign and acknowledge the following Articles of Incorporation, in duplicate originals, and states as follows:

ARTICLE I.

The name of the corporation shall be POTLATCH SUPPLIES, INC.

ARTICLE II.

The general nature of the business of the corporation and the objects and purposes proposed to be transacted, promoted and carried on by it, are as follows:

1. To have such powers as are conferred upon corporations under the laws of this state, and to transact any and all business for which corporations may be incorporated under the laws of the State of Idaho.

ARTICLE III.

The corporation is to have perpetual existence.

ARTICLE IV.

The registered office of the corporation is to be

located at Rt. 1, Box 165 A, Potlatch, Idaho, 83855, and CALVIN RAUGUST is its registered agent at that address.

ARTICLE V.

The authorized capital stock of the corporation shall be Five Hundred and no/100 Dollars (\$500.00) consisting of 500 shares of commn stock having a par value of One Dollar (\$1.00) each.

ARTICLE VI.

The amount of paid-in capital with which this corporation will begin business is the sum of Five Hundred and no/100 Dollars (\$500.00), and this corporation will not commence business until consideration of at least Five Hundred and no/100 Dollars (\$500.00) has been received for the issuance of shares of the capital stock.

VII.

The management of this corporation shall be vested in a Board of Directors; the number of directors shall not be less than one (1); and the number, qualifications, terms of office, manner of election, time and place of meeting, and powers and duties of the directors shall be such as are prescribed by the Bylaws of the corporation.

VIII.

The authority to make Bylaws for the corporation is hereby expressly vested in the Board of Directors of this corporation, subject to the power of the shareholders to change or repeal such Bylaws. The Board of Directors shall not make or alter any Bylaws fixing their qualifications, classifications, terms of office or compensation.

ARTICLE IX.

The corporation reserves the right to amend, alter, change or repeal any provision contained in these Articles of Incorporation in the manner now or hereafter prescribed by statute, and all rights conferred on the stockholders herein are granted subject to this reservation.
