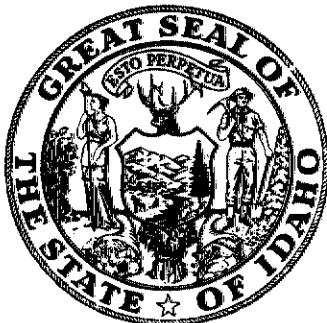

The undersigned, acting as incorporators of a corporation under the Professional Service Corporation Act of the State of Idaho adopt the following Articles of Incorporation for such corporation:

1. NAME: The name of the corporation is BURLEY VETERINARY HOSPITAL, P.A.

2. DURATION: The period of its duration is perpetual.

3. PURPOSE OR PURPOSES: The purpose or purposes for which the corporation is organized are the furnishing of professional veterinary services and veterinary medicine. The corporation shall have such further purposes under the Business Corporation Act of the State of Idaho to the extent the same are not inconsistent with the Professional Corporation Act.

4. CAPITAL: The aggregate number of shares which the corporation shall authority to issue is Twenty-five Thousand (25,000) shares of stock without par value. All stock shall be voting common stock.

5. PRE-EMPTIVE RIGHTS: There are no provisions denying pre-emptive rights.

6. INTERNAL AFFAIRS: There are no provisions for the regulation of internal affairs of the corporation as those will be stated in the By-Laws.
