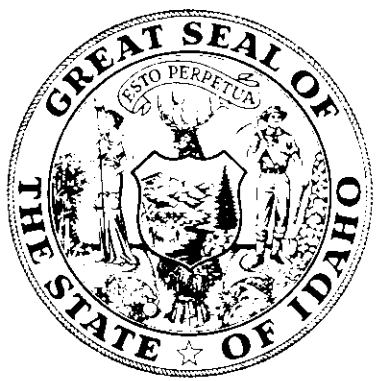

Pursuant to Section 30-1-119, Idaho Code, the undersigned corporation, CASTLE & COOKE, INC., Secretary of State
