## ARTICLES OF INCORPORATION

## GEM STATE CHEMICAL CO.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all being of full age and citizens of the United States, have this day voluntarily associated curselves together for the purpose of forming a corporation under the laws of the State of Idaho.

And we hereby certify:

I.

That the name of said corporation shall be "GEM STATE GHEMICAL CO."

II.

That the purposes for which said corporation is forced are:

- (1) To engage in the buying, selling, manufacturing and distributing of all kinds of chemicals, chemicals products and all pther types and kinds of goods, wares and merchandise.
- (2) To contract with other manufacturers and distributors of chemicals, chemical products and all other types and kinds of goods, wares and merchandise for the manufacture of, and distribution of chemicals, chemical products and all other types and kinds of goods, wares and merchandise.
- (3) To buy, sell, trade, and deal in and with any and all kinds of chemicals, chemical products and all other types and kinds of goods, wares and merchandise as broker, factor or agent of others as well as for the account of said corporation itself.
- (4) To transport, handle and store all kinds of chemicals, chemical products and all other types and kinds of goods, wares and merchandise.
- (5) To purchase, lease, own, sell, mortgage, sub-lease, and otherwise acquire and dispose of lands, buildings, easements and all rights in real property as well as personal property, and

to enter into, make, perform and carry out contracts of every sort and kind with any person and to acquire and take over the good will, property, rights, franchises and assets of every kind and the liabilities of any person, firm, association or corporation either in whole or in part and to pay for the same in cash, stock or bonds of the corporation or otherwise.

- the account of said corporation and to issue debentures or other evidences of indebtedness therefor and to obligate the assets of the corporation as security for such indebtedness; to act as surety and guaranter in any and all types of engagements including the power to execute, endorse and deliver contracts, and to guarantee the prompt and faithful performance and payment of debts, notes, agreements, contracts and undertakings of any other person, firm, partnership or corporation; and including also the power to act as an accommodation, co-maker or guaranter of obligations either as primary or secondary obligor.
- (7) In the purchase of or acquisition of property, business rights or franchises or for any other object in and about its business or affairs, to incur debt and to borrow and secure the payment of money in any lawful manner including the issue and sale or other disposition of bonds, debentures, notes and other evidences of indebtedness.
- (8) Without in any particular limiting any of the objects or purposes or powers of the corporation, the business or purposes of the company shall be from time to time to do any one or more or all of the acts and things herein set forth and to engage in the business of dealing in and manufacturing of all kinds of chemicals, themical products and all other types and kinds of goods, ware and merchandise and all such other acts, things and business in any way connected therewith or auxiliary thereto.

III.

That the term for which said corporation shall exist is lifty (50) years.

That the number of directors of said corporation shall be Three (3).

V.

That the registered office and principal place of business of said corporation in the State of Idaho shall be located in Twin Falls, in the County of Twin Falls, and that the post office address of the registered office of said corporation in the State of Idaho is Box 230, Twin Falls, Idaho.

VI.

That the amount of capital stock of said corporation shall be Ten Thousand Dollars (\$10,000.00) divided into one hundred (100) shares of the par value of One Hundred Dollars (\$100.00) each and that the total authorized number of shares shall be one hundred (100) and their aggregate par value Ten Thousand Dollars (\$10,000.00).
