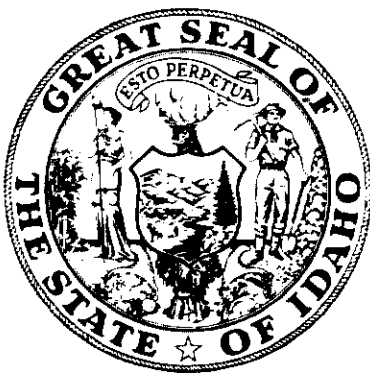

Voluntary Dissolution by Incorporators
(Idaho Code 30-1-82)






