ARTICLES OF INCORPORATION

OF

LORI YOUNG INC.

An Idaho Corporation

I, the undersigned, acting as the incorporator of a corporation under the Idaho Business Corporation Act, adopt the following articles for such corporation:

FIRST: The name of the corporation is Lori Young Inc., an Idaho Corporation.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized is providing nail care services to the general public and all other lawful purposes allowed under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 100,000 shares with a one dollar (\$1.00) par value.

FIFTH: The shareholders shall have the preemptive right to acquire additional or treasury shares of the corporation.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are:

- a. The corporation shall have the right to purchase its own shares out of retained earnings to the extent of the unreserved and unrestricted amount of such earnings available therefore.
- b. The corporation may, by its by-laws, provide restrictions on the sale or other disposition of its shares and on the transfer thereof by providing preemptive or prior rights to the corporation or its shareholders

to purchase any of its shares offered for transfer.

- c. The Board of Directors may from time to time distribute to the shareholders in partial liquidation of its capital of the corporation, a portion of its capital of the corporation, a portion of its assets in cash or property, subject to the provisions of the Idaho Business Corporation Act.

SEVENTH: The address of the initial registered office of the corporation is 2370 Elliott #13, Eagle, Idaho, and the name of its initial registered agent at such address is Lori Young.

EIGHTH: The number of directors constituting the initial Board of Directors of the corporation is one (1) and the names and addresses of the person who is to serve as director until the first annual meeting of shareholders or until a successor is elected and shall qualify is:

NINTH: The number of directors to be elected at the annual meeting of shareholders next following the time when the shares of the corporation become owned beneficially or of record by more than one shareholder, as the case may be, or at a special meeting called for the election of directors after such time, shall not be less than the number of shareholders.
