ARTICLES OF INCORPORATION

OF

LORI YOUNG INC.

An Idaho Corporation

I, the undersigned, acting as the incorporator of a corporation under the Idaho Business Corporation Act, adopt the following articles for such corporation:

FIRST: The name of the corporation is Lori Young Inc., an Idaho Corporation.

SECOND: The period of is duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized is providing nail care services to the general public and all other lawful purposes allowed under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 100,000 shares with a one dollar (\$1.00) par value.

FIFTH: The shareholders shall have the preemptive right to acquire additional or treasury shares of the corporation.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are:

- a. The corporation shall have the right to purchase its own shares out of retained earnings to the extent of the unreserved and unrestricted amount of such earnings available therefore.
- b. The corporation may, by its bylaws, provide restrictions on
 the sale or other disposition
 of its shares and on the transfer thereof by providing preemptive or prior rights to the
 corporation or its shareholders

to purchase any of its shares offered for transfer.

from time to time distribute
to the shareholders in partial
liquidation of its capital of
the corporation, a portion of
its capital of the corporation,
a portion of its assets in cash
or property, subject to the
provisions of the Idaho Business Corporation Act.

EIGHTH: The number of directors constituting the initial Board of Directors of the corporation is one (1) and the names and addresses of the person who is to serve as director until the first annual meeting of shareholders or until a successor is elected and shall qualify is:
