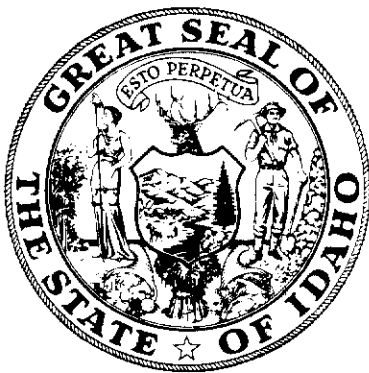

FIRST: The name of this Corporation is Betty and Don's Music, Inc.

SEDOND: AMENDMENTS

The FIRST article of the Articles of Incorporation of said corporation shall be amended by deleting it in its entirety and substituting therefor the following:

The name of this Corporation is AMERICAN MUSIC, INC.

THIRD: DATE OF ADOPTION

The Amendment has been approved by the Board of Directors of said Corporation at a meeting held on the 2nd day of January, 1987, at which meeting there was at all times a quorum of the Board of Directors. The issue was submitted to a special meeting of the shareholders on the same date, at which time the corporation name change was approved.

FOURTH: NUMBER OF SHARES

The number of shares outstanding and entitled to a vote are 20,000 shares.

FIFTH: VOTE

The entire 20,000 shares voted in favor of this Amendment to change the corporate name to AMERICAN MUSIC, INC.

SIXTH: EFFECT ON ISSUED SHARES AND STATED CAPITAL

The Amendment does not provide for an exchange, reclassification or cancellation of issued shares, nor does it effect a change in the amount of stated capital.
