



Preamble

The undersigned officers of the Friendly Senior Citizens of Troy, Inc., do hereby set forth and adopt the following Articles of Incorporation for the purpose of formally and publicly establishing this non profit organization and to guide it's affairs and operations.

Article I Name

The name by which this corporation shall be known is "Friendly Senior Citizens of Troy, Inc.".

Article II Purpose

The purposes for which this corporation is organized includes but is not limited to the following items:

- A. In order to carry out these purposes, the Friendly Senior Citizens of Troy, Inc., hereafter referred to as The Corporation, will organize, function and be authorized to do business under the provisions of Chapter 3, Title 30 of the Idaho State Code as a non profit corporation.
- B. To promote the social welfare and physical well being of elderly residents of the City of Troy, Idaho, and it's surrounding area, hereafter referred to as the Troy Area, through the development of comprehensive and coordinated services.
- C. To defend the human and civil rights of the elderly people in the Troy Area by improved communications through sponsorship of regular social gathering and informational programs.
- D. To assist in the relief of distressed and underprivileged elderly persons of the Troy Area.
- E. To promote and support the better interests of the Troy Area generally.
- F. To provide The Corporation with the power to purchase, lease or otherwise acquire real and personal property, said property to become the possession of Friendly Senior Citizens of Troy, Inc.
- G. To provide The Corporation with the power to enter into contracts or obligations of any type or kind necessary or proper for the accomplishment of purposes for which The Corporation accomplishment of purposes for which The Corporation are expedient for the spacetime or benefit of The Corporation, or in the furtherance of the state of the corporation.

Article VI Membership

The Corporation will have members. No stock will be issued and each member will have one (1) vote on each matter to be brought up before the membership to be voted on. Members will normally consist of retired and elderly persons of the Troy Area. Specific age and residency requirements will be set forth in The Corporation by-laws. Dues, if any, will be determined and set forth in The Corporation by-laws. No person shall be excluded from membership because of race, color, gender, religion, national origin or disability.

Article VII Dissolution

In the event of a decision by the Board of Directors to dissolve The Corporation, any remaining assets will be liquidated and the resulting funds, along with any residual funds in the custody of the treasurer at that time, shall be donated to the Troy Ambulance Fund of Troy, Idaho. In the event the Troy Ambulance Fund or its successor is no longer in existence, the funds will be donated, by a decision of the Board of Directors, to another non-profit organization in the Troy Area.

Article VIII Management

The Corporation shall be managed by a board of directors consisting of a President, who will also act as Chairman of the Board, a Vice President, a Secretary and a Treasurer, all of whom will be elected annually by the membership. Additional board positions may be defined as required and directors appointed to fill those positions by the board of directors as defined in the by-laws of The Corporation. The qualifications, responsibilities and terms of office for each board member shall be set forth in the by-laws of The Corporation.

Article IX By-laws

Shortly after incorporation, a set of by-laws will be drafted as the rules and regulations under which The Corporation will operate. The by-laws will provide, in a manner not inconsistent with State and Federal law, the defining, limiting and regulating of powers of The Corporation, its board of directors and members. The by-laws will also set forth any provisions required and may set forth other provisions as permitted by the Idaho Non Profit Corporation Act. The initial by-laws will be adopted by the board of directors and approved by a majority of the members present at a regular or special meeting called for that purpose.

Article X Annual Report

The Corporation shall file an annual report with The Secretary of State of the State of Idaho as required in Chapter 3, Title 30, Section 136 of the Idaho Code.
