ARTICLES OF AMENDMENT

TO

ARTICLES(LOF) INGORPORATION OF VALLEY LAWN CARE, INC. SEC. OF STATE

Well Mithe 8 undersigned incorporators of VALLEY LAWN CARE, INC., do hereby certify and adopt these Articles of Amendment to the Articles of Incorporation (which Articles of Incorporation were dated January 25, 1991, and filed of record with the Idaho Secretary of State on January 28, 1991), as follows:

FIRST: The name of this corporation shall be "GREENACRES, INC.", effective upon the issuance of the Certificate of Amendment by the Secretary of State of the State of Idaho, and ARTICLE I is hereby amended accordingly.

SECOND: Subpargraph A. of Article III is hereby amended to state as follows:

[The corporation's purposes are:]

A. To engage in the business of lawn care and maintenance, landscaping, pest control, and retail sales of products relating thereto.

THIRD: There are no shares outstanding, as no shares have yet been issued by this corporation. These Articles of Amendment to the Articles of Incorporation have been adopted on March 4, 1991, by resolution of all of the original incorporators of this corporation.

FOURTH: Except as otherwise specifically amended by these Articles of Amendment to the Articles of Incorporation, the Article of Incorporation of this corporation shall remain and continue in full force and effect.
