ARTICLE ONE

The name of the Organization is **INDEPENDENT ORDER OF MISSIONARY MEDICINE, Inc.** ("the Organization")

ARTICLE TWO

The Organization is a non-profit Organization.

ARTICLE THREE

The period of its duration is perpetual.

ARTICLE FOUR

The Organization is organized exclusively for charitable, religious, educational, and or scientific purposes, including, for such purposes, the making of and distribution to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE SEVEN

This organization is a sponsorship of QUANTUM-VERITAS International University Systems (QVIUS) and composed of voting members made up of QVIUS alumni, medical professionals, practitioners and the general public. No part of the net earnings of this Organization shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the Organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Four hereof. No substantial part of the activities of this Organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Organization shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of any candidate for public office.

ARTICLE EIGHT

Notwithstanding any other provision of these Articles, the Organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding provisions of any future Federal Tax Code, or (b) by a Organization, contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future Federal Tax Code.

ARTICLE NINE

Upon the Dissolution of this Organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any further Federal Tax Code, or shall be distributed to the federal government, or to a state of local government, for a public purpose.


