ARTICLES OF INCORPORATION

WE, THE UNDERSIGNED natural persons of the age of eighteen years or more, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I -- NAME

The name of this corporation is: BAR-H-BAR RANCH, INC.

ARTICLE II -- DURATION

The duration of this corporation is: Perpetual.

ARTICLE III -- PURPOSES

- a. The purpose for which the corporation is formed is to provide recreational working vacations in a ranch setting and to do all things and engage in all lawful transactions which a corporation organized under the laws of the State of Idaho might do or engage in, even though not expressly stated herein.
- b. To do each and every thing necessary, suitable or proper for the accomplishment of any of the purposes or the attainment of any one or more of the subjects herein enumerated, or which may at any time appear conducive to or expedient for protection or benefit of this corporation, and to do said acts as fully and to the same

extent as natural persons might, or could do, in any part of the world as principals, agents, partners, trustees or otherwise, either alone or in conjunction with any other person, association or corporation.

c. The foregoing clauses shall be construed both as purposes and powers and shall not be held to limit or restrict in any manner the general powers of the corporation, and the enjoyment and exercise thereof, as conferred by the laws of the State of Idaho; and it is the intention that the purposes and powers specified in each of the paragraphs of this Article III shall be regarded as independent purposes and powers.

ARTICLE IV -- STOCK

The aggregate number of shares which this corporation shall have authority to issue is 10,000 shares of no par value stock. All stock of the corporation shall be of the same class, common, and shall have the same rights and preferences. Fully-paid stock of this corporation shall not be liable to any further call or assessment.

ARTICLE V -- AMENDMENT

These Articles of Incorporation may be amended by the affirmative vote of sixty-seven percent (67%) of the shares entitled to vote on each such amendment.

ARTICLE VI -- SHAREHOLDER RIGHTS

The authorized and treasury stock of this corporation may be issued at such time, upon such terms and conditions and for such

consideration as the Board of Directors shall determine. Shareholders shall have preemptive rights to acquire unissued shares of the stock of this corporation.

ARTICLE VII -- CAPITALIZATION

This corporation will not commence business until consideration of a value of at least \$1,000 has been received for the issuance of shares.

ARTICLE VIII -- INITIAL OFFICE AND AGENT
