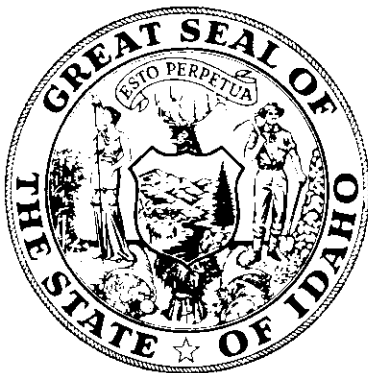

FIRST: The name of the corporation is R & B MARKET OF CALDWELL, INC.






