ARTICLES OF INCORPORATION

OF

FAIRGROUNDS SPEEDWAY OPERATIONS & CONCESSIONS, INC.

I, the undersigned person of the age of eighteen years or more, as incorporator of a corporation under the Washington Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE 1.

The name of this corporation is FAIRGROUNDS SPEEDWAY OPERATIONS & CONCESSIONS, INC.

ARTICLE 2.

The corporation has perpetual existence.

ARTICLE 3.

This corporation is organized for the purposes of transacting any and all lawful business for which corporations may be incorporated under Title 23A of the Revised Code of Washington, as amended.

ARTICLE 4.

The address of the registered office of the corporation is West 1311 Sprague Avenue, Spokane, Washington 99204; and the name of the registered agent at such address is Charles G. Little.

ARTICLE 5.

The total authorized number of par value shares of the corporation is Fifty Thousand (50,000) shares of the par value of One and no/100 dollars (\$1.00) per share, amounting in the aggregate to Fifty Thousand Dollars (\$50,000.00).

ARTICLE 6.

Shareholders of this corporation have no preemptive rights to acquire additional shares issued by the corporation.

ARTICLE 7.

The number of directors of this corporation shall be fixed in a manner specified by the by-laws of this corporation. The first directors of the corporation are two (2) in number and their names and addresses are:

The first directors shall serve until the first annual meeting of shareholders and until their successors are elected and qualify.

ARTICLE 8.

ARTICLE 9.

At each election for directors, every shareholder entitled to vote at such election has the right to vote in person or by proxy the number of shares of stock held by him for as many persons as there are directors to be elected. No cumulative voting for directors shall be permitted.

ARTICLE 10.

- (1) No contracts or other transactions between the corporation and any other corporations, and no act of the corporation shall in any way be affected or invalidated by the fact that any of the directors of the corporation are pecuniarily or otherwise interested in, or are directors or officers of, such other corporations; and
- (2) Any director individually, or any firm of which any director may be a member, may be a party to, or may be pecuniarily or otherwise interested in, any contracts or transactions of the corporation, provided that the fact that he or such firm is so interested shall be disclosed or shall have been known to the Board of Directors or the majority thereof.

ARTICLE 11.

The corporation reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Incorporation, in the manner now or hereafter prescribed by law, and all rights and powers conferred herein on shareholders and directors are subject to this reserved power.
