- I. ~~The name of this corporation shall be COLLEGE FINANCIAL AID & ADMISSION SERVICES CENTER, INC.~~
- II. This corporation is a nonprofit corporation.
- III. The period of duration for COLLEGE FINANCIAL AID & ADMISSION SERVICES CENTER, INC. shall be perpetual.
- IV. The purpose for which this corporation is organized is to provide college bound students with assistance in the location and procurement of financial aid for tuition and other school expenses and to provide guidance in the admissions process.
- V. COLLEGE FINANCIAL AID & ADMISSION SERVICES CENTER, INC. shall have no members and whatever powers may have generally been reserved to members shall, in accordance with Title 30, Chapter 1, Idaho Code, be vested in Education Trends 2000, Inc., an Idaho corporation, which has authority to elect the directors pursuant to subsection (e) of section 30-314, Idaho Code.
