ARTICLES OF INCORPORATION
OF
SELF MANUFACTURING CO., INC.

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, WILLIAM G. KOCH, LAVEAR B. THORNOCK, CAROLYN PENCE and HOMER STRADLEY, each residents of the State of Idaho and residing in the County of Twin Falls, Idaho, each and all citizens of the United States of America, of the age of majority, do hereby associate themselves together for the purpose of forming a corporation under the laws of the State of Idaho, and to that end, do hereby adopt and execute the following Articles of Incorporation, and do hereby certify and declare:

I.

That the name of said corporation is and shall be SELF MANUFACTURING CO., INC.

II.

That said corporation is formed for the following purposes:

a. To carry on a general manufacturing, wholesale, and retail business; to manufacture, buy, sell, deal in, and deal with steel and iron, and all like or kindred products; to manufacture, prepare for market, market and sell the same, any articles or product in the manufacture or composition of which metal is a factor, including the acquisition by purchase, manufacture, or otherwise of all materials, supplies, and other articles necessary or convenient for use or connection therewith; to manufacture and construct machines of any kind or character; to maintain and operate a machine shop and activities related thereto; and to do all things incidental or connected with the foregoing mentioned activities.

b. To receive, acquire, hold, purchase, dispose of, convey,

mortgage and/or lease, real and personal property; to dispose of, sell, lease, assign, transfer, mortgage and/or convey any rights, privileges, franchises, real or personal property of the corporation, other than its franchise of being a corporation, and to acquire, purchase, guaranty, hold, mortgage, own, vote, sell, pledge and/or otherwise dispose of and deal in shares, bonds, securities and debentures and other evidences of indebtedness of its own and of other corporations, domestic or foreign.

c. To conduct business in this state, other states, District of Columbia, territories and colonies of the United States and in foreign countries, and to have one or more offices and places of business out of this state, and to acquire, receive, hold, purchase, lease, mortgage, dispose of and/or convey real and personal property situate out of this state.

d. To enter into, make, perform and carry out contracts of every kind and for any lawful purpose, without limit as to amount, with any person, firm, association, corporation, municipality, state or government, or any subdivision, district or department thereof.

e. To do any and all such other acts, things, business or businesses in any manner connected with or necessary, incidental, convenient or auxiliary to any of the objects hereinbefore enumerated, or calculated, directly or indirectly, to promote the interest of the corporation; and in carrying on its purposes, or for the purpose of attaining or furthering any of its business.

f. The several clauses contained in this statement of purposes shall be construed as both purposes and powers, and the statements contained in each clause shall be in nowise limited or restricted, by reference to, or inference from, the terms of any other clause, but shall be regarded as independent purposes and

powers; and no recitation, expression or declaration of specific or special powers or purposes herein enumerated shall be deemed to be exclusive; but it is hereby expressly declared that all other lawful powers not inconsistent herewith are hereby included.

III.

That the location and post office address of the registered office of the corporation shall be Twin Falls, Twin Falls County, State of Idaho.

IV.

That the duration and existence of this corporation is to be perpetual.

V.

That the amount of the authorized stock of said corporation shall be One Hundred Thousand (\$100,000.00) Dollars, divided into four thousand (4,000) shares of common stock at the par value of Twenty Five (\$25.00) Dollars each.


