ARTICLE OF INCORPORATION

OF

BOISE BASIN QUILTERS, INC.

KNOW ALL MEN BY THESE PRESENTS:

That WE, the undersigned person, all of whom are residents of the State of Idaho, citizens of the United States of America, and of full age, have this date voluntarily associated ourselves together for the purpose of forming a non-proft corporation under the provisions of the Idaho Code, and we do hereby make, acknowledge and declare to be our Articles of Incorporation.

ARTICLE I

The name of this corporation shall be BOISE BASIN QUILTERS, INC.

ARTICLE II

This corporation is a non-profit corporation and shall have no capital stock; and no dividends or pecuniary profits shall be declared to the members thereof.

ARTICLE III

This corporation is organized exclusively for charitable, education, or civic support purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1954.

ARTICLE IV

The purposes of this corporation are to contribute to the growth and knowledge of quilting techniques, patterns, history

The period of existence and duration of this corporation shall be perpetual.

ARTICLE VI
