ARTICLES OF INCORPORATION OF THE IDAHO NATURAL GAS VEHICLE USERS ASSOCIATION, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Nonprofit Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I NAME

The name of the corporation is Idaho Natural Gas Vehicle Users Association, Inc.

ARTICLE II DURATION

The period of its duration shall be perpetual.

ARTICLE III PURPOSE

The corporation is organized exclusively to promote social welfare within the meaning of and pursuant to section 501(c)(4) of the Internal Revenue Code of 1986, as amended (or under the corresponding provision of any future United States Internal Revenue law), including for such purposes, but not limited to, educating the public about the benefits of natural gas vehicles and promoting the use of natural gas vehicles to reduce emissions and U.S. dependence on foreign oil. References in these Articles of Incorporation to the "Code" shall be to the Internal Revenue Code of 1986, as amended from time to time.

ARTICLE IV POWERS

The corporation shall have all powers provided for nonprofit corporations under the Idaho Nonprofit Corporation Act.

ARTICLE V LIMITATIONS

- 5.1 The corporation is not organized and shall not be operated for profit and no part of the income or net earnings of the corporation shall inure to the benefit of, or be distributable to, any director or officer of the corporation or any other private individual (except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes, and reimbursement may be made for any expenses incurred for the corporation by any officer, director, agent or employee, or any other person or corporation, pursuant to and upon authorization of the Board of Directors)
- 5.2 No director or officer of the corporation, or any other private individual shall be entitled to share in any distribution of any of the corporate assets on dissolution of the corporation or otherwise.
- 5.3 The corporation shall not participate or intervene in any political campaign on behalf of, or in opposition to, any candidate for public office to an extent that would disqualify it from tax exemption under section 501(c)(4) of the Code.
- 5.4 Upon dissolution of the corporation, all of its assets shall be paid over or transferred to one or more exempt organizations of the kind described in sections 501(c)(3) or 501(c)(4) of the Code, or to one or more government entities, as determined by the corporation's board of directors. Any assets not so disposed of shall be disposed of by a court of general jurisdiction in Ada County, Idaho.
- 5.5 Notwithstanding any other provision hereof, this corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization that is tax-exempt under the provisions of section 501(c)(4) of the Code.

ARTICLE VI NO MEMBERS

The corporation shall have no voting members and all business affairs of the corporation shall be conducted by its Board of Directors.

ARTICLE VII BOARD OF DIRECTORS

All business affairs of the corporation shall be conducted by its Board of Directors. The number of directors serving on the Board of Directors shall be fixed in accordance with the corporation's Bylaws. The names and addresses of the persons who are to serve as the initial directors are:
