-+ARTICLES OF INCORPORATION:--

ARTICLE I.

That the name of this incorporation shall be "The Twin Falls Social Club"

ARTICLE II.

That this incorporation is formed for the purpose as follows to wit;

That the Citizens of the said City of Twin Falls in Cassia County State of Idaho, may have a place of meeting wherein and whereby they the said Citizens of the said City of Twin Falls in said County and State aforesaid may associate themselves together for social inter-tainment and for such other reason and business as may be proper and consistant with the laws of the State of Idaho, and that the members thereof may have a place of meeting for social purposes and to transact such other business as may properly come before said corporation.

ARTICLE III.

That the Principal place of Business of The Twin Falls Social Club" (a corporation) shall be at Twin Falls in Cassia County State of Idaho and that the business of said Corporation shall be transacted in the said City aforesaid.

ARTICLE IV.

That the term for which this corporation shall exist shall be Twenty Five years.

ARTICLE V.

That this Corporation shall have a President, Secretary and Treasurer who's names are as follows to wit: W.S. McQuain President, who resides at Twin Falls in said County and State aforesaid Charles Walters, Secretary who resides at Twin Falls in said County and State aforesaid, and W.S. McGuire Treasurer, who resides at Twin Falls in said County and State aforesaid, and that the said S.W. McQuain and Charles Walters, whos said residence is at said Twin Falls in said County and State have been and are hereby appointed directors of said corporation for the ensuing year.

# ARTICLE VI.

That the Capital stock of the said Corporation is and shall be the sum of One Thousand Dollars divided into One Thousand shares of the par value of One Dollar each and shall be fully paid up and non assessable.

That the full amount of the said Capital stock has been fully <sup>sub-</sup>scribed and fully paid by the following named persons to wit:-




