ARTICLES OF INCORPORATION

of

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, being natural persons of full age, citizens of the United States of America, and residents of the State of Idaho, this day have voluntarily associated ourselves for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho and we do hereby certify as follows:

1.

NAME

The name of this corporation shall be R. & L., Inc.

2.

PURPOSE

The purposes for which this corporation is formed are:

- a. To engage in and carry on recreation roller skating business.
- b. To lease or rent facilities and to operate, sell and service roller skates, equipment, apparel and supplies.
- c. To generally conduct, operate and manage roller skating rink or rinks within the State of Idaho.

DURATION

The existence of this corporation shall be perpetual.

REGISTERED OFFICE

The principal place of business and registered office of this corporation shall be at Grangeville, Idaho County, Idaho.

STOCK

This corporation is authorized to issue one class of stock, the total number of which is 500 with a par value of \$10,00, for an aggregate total of \$5,000.00, which stock may be issued by the corporation from time to time as determined by the Board of Directors thereof.
