That the name of this corporation is and shall be "DECKER DOMESTIC WATER CO."

II.

That the purposes for which said corporation is formed are:

- a. To conduct and carry on the business of supplying domestic and irrigation water to the stockholders of this corporation;
- To engage in laying pipes and conducting such water to consumers;
- c. To build and maintain ditches, canals, pipes and aqueducts, together with the necessary pumps, siphons and appliances for the conducting of said water;
- d. To buy, lease or exchange real or personal property, including easements, such as may be necessary in supplying the water to the stockholders of this corporation;
- e. To acquire machinery, fixtures, appliances, trucks and other neterials and property as this corporation may deem necessary to carry into effect and to perpetuate the purposes for which said corporation was organized and exists;
- f. To sell, convey, lease, assign, mortgage or otherwise encumber or dispose of any and all real or personal property, and to do and perform all such acts and things as may be required and necessary in the premises of engaging in the general business as hereinbefore set out by and through these Articles of Incorporation, and in accordance with the laws of the State of Idaho; and
- g. To engage in and conduct any legal business not for pecuniary gain or profit to the members hereof.

That this corporation can furnish water only to its registered paid up stockholders.
