- (c) The limited partners have each agreed to make additional contributions ("Overcalls") upon written notice from the general partners up to, but not exceeding, 20% of the sum of his agreed cash contributions as set forth in paragraphs 6(a) and 6(b) above, but not exceeding 10% in any calendar year.
- After reduction for losses and distributions theretofore made, the contributions of each limited partner shall be returned to him upon the termination of the limited partnership and the abandonment of further intention of exploiting the properties of the partnership.
