Article I

Name

The name of the corporation shall be ARCHITECTURE NORTHWEST, P.A.

Article II

Duration

The duration of this corporation is perpetual.

Article III

Purpose

The purpose of the corporation is to engage in any type of service to the public which can be rendered by a member of the profession of architecture and any allied professional services as defined by Idaho Code §30-1303.

Article IV

Stock

The corporation will have the authority to issue 1,000 shares of capital stock with no par value.
