KNOW ALL MEN BY THESE PRESENTS, that WE, the undersigned incorporators being of the age of eighteen years or more, desiring to organize a corporation under the laws of the State of Idaho, do hereby make, sign and verify these Articles of Incorporation.

ARTICLE I

The name of the corporation is PHYSICIAN ASSISTANTS EMERGENCY MEDICINE, P.A.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The corporation is organized for the pursuit of providing medical services for which physicians assistants are authorized pursuant to Idaho Code § 54-1807(2), and for all related purposes necessary and incidental thereto, and for no other purpose.

ARTICLE IV

The corporation is authorized to issue one class of shares, in a total amount of 5,000 shares. The stock shall bear no par value.
