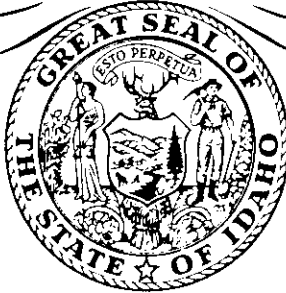

ARTICLES OF INCORPORATION
OF
STYLEBILT HOMES INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all of whom are full aged citizens of the United States of America and are bona fide residents of the State of Idaho, have this day voluntarily associated ourselves, and do by these articles of incorporation unite ourselves under the laws of the State of Idaho, for the purpose of forming a corporation, and we hereby certify:

I.

That the name of the corporation shall be STYLEBILT HOMES INC.

II.

That the purposes for which said corporation is formed are as follows:

To engage in the general construction business.

To buy, sell, deal in, lease, hold or improve real estate, and with that end in view to acquire, by purchase, lease, hire or otherwise deal in, lands, tenements, hereditaments, or any interest therein, and to improve the same, and generally to hold, manage, deal with and improve the property of the company, and to sell, lease, mortgage, pledge, or otherwise dispose of the lands, tenements and hereditaments or other property of the company; to construct, erect, equip, repair and improve houses, buildings, public or private roads, alleys, and reservoirs; to make, enter into, perform and carry out contracts for constructing, altering, decorating, maintaining, furnishing, fitting up and improving buildings of every sort and kind; to advance money

to, and enter into contracts and arrangements of all kinds with builders, contractors, decorators, dealers in stone, brick, timber, hardware and other building materials or requisites.

To borrow money; to lend money; to conduct a general brokerage, agency and commission business for others in the purchase, sale and management of real estate; to purchase and sell for others personal property, stocks, bonds, and notes, and to negotiate loans thereon for others; to act as trustee in deeds of trust or mortgages on real or personal property or any evidences of value to secure them; and to act as agents for letting houses and lands and the collection of rents and the payment of taxes.

In general to do any business which a natural person may do under the laws of the State of Idaho.

III.

The period of existence of this corporation shall be perpetual.

IV.

The registered office and place at which the principal business of this corporation shall be conducted is the City of Coeur d'Alene, County of Kootenai, State of Idaho.

V.

The total authorized stock of this corporation shall be Five Thousand Dollars (\$5,000.00) divided into 5,000 shares of the par value of \$1.00 per share.
