Articles of Incorporation of

THINK L., INC.

WE, THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following articles of incorporation for such corporation:

- FIRST:** The name of the corporation is THINK L. INC.
- SECOND:** The period of its duration is Perpetual
- THIRD:** The purpose(s) for which the corporation is organized are to purchase, take, receive, lease or otherwise acquire, own, hold, improve, use and otherwise deal in and with, real or personal property, or any interest therein, wherever situated and transact any lawful business for which corporations may be incorporated under this act.
- FOURTH:** The aggregate number of shares which the corporation shall have authority to issue is 50,000 of common stock, one class only with a par value of \$10.00 (ten dollars) each.
