

Articles of Incorporation of McCall Kayak Club LTD

Article 1: The name of the corporation shall be McCall Kayak Club LTD.

Article 2: The purpose for which the McCall Kayak Club LTD is organized is to provide for educational purposes, including, for such purposes, instruction of whitewater kayaking to young people so as to further a sense of stewardship for the place in which they live and the making and distributions to organizations that qualify as exempt organizations under 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. No part of the net earnings of the McCall Kayak Club LTD shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the McCall Kayak Club LTD shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 2 hereof. No substantial part of the activities of the McCall Kayak Club LTD shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the McCall Kayak Club LTD shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the McCall Kayak Club LTD shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article 3: The street address of the registered office is 1103 Alpine Street McCall, ID 83638 and the registered agent at such address is Fred Coriell.

Article 4: The board of directors shall consist of no fewer than three (3) people. The names and addresses of the initial directors are:



Article 7: The McCall Kayak Club LTD does not have voting members.

Article 8: Upon dissolution the assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the McCall Kayak Club LTD is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
