3. The notice required by section 30-1-87, Idaho Code was given not less than 30 days prior to the date of execution of these Articles of Dissolution.


4. All debts, obligations, and liabilities of the corporation have been paid and discharged or adequately provided for.

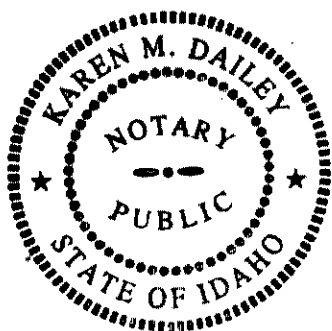
