

I, the undersigned natural person of the age of twenty-one years or more, acting as incorporation under the Oregon Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I

The name of the Corporation shall be PARK - DAVIS WESTERN CORPORATION, and its duration shall be perpetual.

ARTICLE II

The initial registered office of the Corporation in the State of Oregon is 2520 S.W. Multnomah Blvd., Portland, Oregon 97219, and the initial registered agent for the Corporation is Larry Davis.

ARTICLE III

The purpose and powers of the Corporation are:

- 1. To engage in any lawful activity for which the Corporations may be organized under ORS Chapter 57.
- 2. To engage in any lawful activity and to do anything in the operation of this Corporation or the accomplishment of any of its purposes or for the exercise of any power herein set forth which shall appear necessary or beneficial to this Corporation in connection therewith.

ARTICLE IV

The aggregate number of shares which the Corporation shall have authority to issue shall be Five Thousand (5,000) shares of common stock of one class, without par value.
