ARTICLES OF INCORPORATION

OF

GEORGE AND HENRY'S OK TIRE STORE, INC.

We, the undersigned, natural persons of legal age, and citizens of the United States, in order to form a corporation for the purposes hereinafter stated, pursuant to the General Business Corporation Act for the State of Idaho as set forth in Title 30 of the Idaho Code do hereby certify as follows:

ARTICLE I

The name of the corporation is: GEORGE AND HENRY'S OK TIRE STORE, INC.

ARTICLE II

The purposes for which said corporation is formed and the powers of said corporation are as follows:

- (A) To buy, import, or otherwise acquire, and to distribute, export, sell or otherwise dispose of either by wholesale or retail tires, inner tubes, and related items incident to the general purpose of operating an automotive tire store. To design, manufacture, buy and sell, and import and export supplies and accessories for automobiles, automobile trucks, and tractors of every make; to repair, reconstruct, and overhaul automobiles, automobile trucks, and tractors of all kinds andmakes.
- (B) To engage in the business of buying and selling gasoline, lubricating oils and other supplies and parts in and for automobiles and tractors. To operate gas filling stations, automobile car washes, to repair tires, align automobile wheels, lubricate and wash cars and do everything ordinarily done by those engaged in the line of the sale of automobile tires, accessories, and engaged in the repair, storage or other service in and to the automotive industry.
- (C) To acquire by purchase, lease or otherwise, lands and interests in lands, and to own, hold, improve, develope and manage any real estate so acquired, including the right to mortgage the same.
- (D) In general, the nature of the business and the objects and purposes of the corporation to be transacted, promoted or carried on by the corporation are to engage in any lawful act or

activity for which corporations may be organized under the General Corporation Law of the State of Idaho.

The above includes the right to borrow money, or raise money without limit to amount, sell, create security interests in, pledge, and otherwise dispose of and realize upon book accounts and other choses in action; to make, draw, accept, endorse, execute, and issue bonds, debentures, notes and other obligations of any nature or in any manner for money so borrowed or in payment for property purchased or any other of the objects or purposes of this corporation, and to secure the principal thereof and interest thereon by mortgage, or creation of security interests in or pledge of, or conveyence or assignment in trust of, the whole or any part of the property, real or personal, of this corporation, wherever situated and whether at the time owned or thereafter acquired; and, in such a manner and upon such terms as the Board of Directors may from time to time determine, to sell, exchange, pledge, offer for discount, or otherwise dispose of any and all such bonds, debentures, notes, or other obligations.

To purchase, own or hold and sell or transfer but not to vote its own shares or securities. From time to time to provide and carry out and recall, abolish, revise, amend, alter, or change a plan or plans for the participation by all or any of the employees including directors and officers of the corporation or of any corporation in which the welfare of which the corporation has any interest, and those actively engated in the conduct of this Corporation's business, in the profits of this Corporation or in any branch or division thereof, as part of this corporation's legitimate business expense, and for the furnishing to such employees or persons or any of them of this corporations expense of medical services, insurance against accidents, sickness or death, pensions during old age, disability, employee stock ownership plans, or unemployment, education, housing, social services, recreation, or other similar aids for their relief or general welfare, in such manner and upon such terms and conditions as may be determined by the Board of Directors.

ARTICLE III

This corporation shall have perpetual existence.

ARTICLE IV

The location and registered office of the Corporation

ARTICLE V

The total authorized number of par value shares is Two Hundred Fifty Thousand (250,000) of the par value of \$1.00 per share. All shares are to be Common voting shares.
