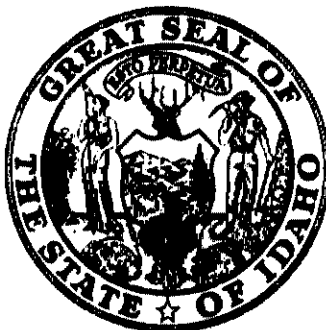
CERTIFICATE OF INCORPORATION OF

**ARTICLES OF INCORPORATION
OF
MICHIGAN PROPERTIES INC. OF IDAHO**

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation is MICHIGAN PROPERTIES INC. OF IDAHO.

ARTICLE II

The period of the corporation's duration is perpetual.

ARTICLE III

The purposes for which the corporation is organized are to transact any and all lawful business for which corporation may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

This corporation is authorized to issue 100,000 shares of common stock with no par value.

ARTICLE V


