The undersigned person, in order to form a corporation pursuant to the Business Corporation Act of the State of Idaho, certifies:

#### ARTICLE I

The name of this Corporation is: Idaho Management Consultants, Inc. Thornton

The period of existence and duration of the life of the Corporation shall be perpetual.

affairs of the The activities and Section 1. Corporation shall be managed by a Board of Directors. The number of Directors which shall constitute the whole Board shall be as stated in Article VI or as altered from time to time by or in the manner provided in the Bylaws. The Board of Directors shall be elected by the members at the annual meeting of the Corporation to be held on such date as the Bylaws may provide, and shall hold office for such term as the Bylaws may provide or until their successors are respectively elected and qualified. The Bylaws shall specify the Board of Directors necessary to constitute a The Corporation or Board of Directors may elect such officers as the Bylaws may specify, who shall, subject to the provisions contained herein, have such titles and exercise such duties as the Bylaws may provide. The Board of Directors is expressly authorized to make, alter, amend or repeal the Bylaws of this Corporation.
