ARTICLES OF INCORPORATION

OF

TEL-CAR, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all being of full age and citizens of the United States, have this day associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho and do hereby adopt articles of incorporation as follows:

ARTICLE I

That the name of the proposed corporation is TEL-CAR, INC.

ARTICLE II

The purposes of the corporation are as follows:

- 1. To operate as a communications common carrier for the purpose of supplying radio communications on a lease and sale basis.
- 2. To acquire from the Federal Communications
 Commission various communications licenses for the purpose
 of supplying the aforementioned radio communications on
 a lease and sale basis.
- 3. To buy, sell and lease real and personal property for the purpose of supplying radio communications as aforementioned on a lease and sale basis.

4. To negotiate for rights of way with the Bureau of Land Management and United States Forest Service for the purpose of supplying radio communications as aforesaid on a lease and sale basis.

5. To engage in any business whatsoever, either as principal or as agent, or both, which the corporation may determine convenient or proper in furtherance of any of the purposes hereinabove mentioned or otherwise; and to have and acquire all powers authorized by the laws of the State of Idaho under which the corporation is formed, whether expressly set forth in this article or not, as such laws are now in effect or may at any time hereafter be amended or enacted.

ARTICLE III

The duration of the corporation shall be perpetual.

ARTICLE IV

The location and post office address of the corporation is East Highway 30, Meridian, Idaho.

ARTICLE V

The total capitalization of the corporation shall be \$30,000.00, divided into 300 par value shares of the value of \$100. These shares shall be non-assessable.

ARTICLE VI

The method and manner of holding directors

These articles may be amended in any respect conformable to the laws of the State of Idaho and by the vote of the required percentage of stockholders as required by the laws of the State of Idaho in a meeting of stockholders called for that purpose as prescribed by law.
