SEC. 1  
STATE Articles of Incorporation of the undersigned, desiring to form a Non-Profit Corporation  
under the Non-Profit Corporation Law of Idaho, do hereby certify:

Article 1

The name of the Corporation shall be: Racing Unlimited, Inc.

Article 2

The principal office of the corporation is initially located at 6957 West Elm Brook Drive,  
in the city of Boise, Ada County, Idaho.

Article 3

The purposes for which the corporation is organized are as follows:

- A. Promote health and fitness through educational material and resources to the public including, but not limited to special events, clinics, dissemination of educational materials, lectures, publications, or otherwise.
- B. Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 c(3) of the Internal Revenue Code, or the corresponding section of any future tax code.

Article 4

## Article 5

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to reimburse expenses reasonably incurred and pay reasonable compensation for services rendered to or for the corporation affecting one or more of its purposes, and to make payments and distributions in furtherance of the purposes set forth in Article 3 hereof.

## Article 6

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles or exercise any powers that are not in furtherance of the purposes of the corporation.

## Article 7

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 c(3) of the Internal Revenue Code, or the corresponding section of any future deferral tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not so disposed shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are operated exclusively for such purposes.
