Such rights shall include the right to be paid or reimbursed by the Company for expenses incurred in defending any such proceeding in advance of its final disposition to the maximum extent permitted under and in accordance with the provisions of the Idaho Business Corporation Act, as the same exists or may hereafter be amended.
