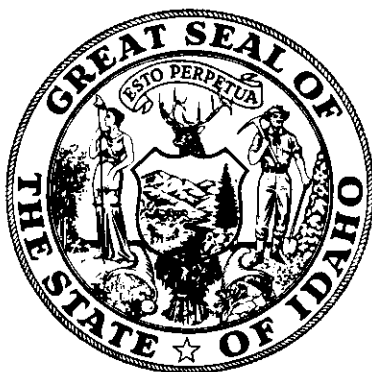

ARTICLES OF INCORPORATION  
OF  
JAMES W. BALTZELL, M.D. P.A.

KNOW ALL MEN BY THESE PRESENTS: That the undersigned, being a duly licensed physician, qualified to practice surgery and medicine pursuant to the laws of the State of Idaho, in order to form a professional corporation for the purposes hereinafter stated, pursuant to the Professional Service Corporation Act and Idaho Business Corporation Act, does hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation shall be JAMES W. BALTZELL, M.D. P.A.

ARTICLE II

The purposes for which said corporation is formed are:

A. To carry on the profession of the practice of surgery and medicine, provided that such professional services shall be rendered only through officers, employees, and agents who are duly licensed under the laws of the State of Idaho to practice surgery and medicine.

B. To have, exercise and enjoy all of the powers now or hereafter granted to professional corporations organized under the laws of the State of Idaho, particularly all of the powers and privileges granted to corporations by the Idaho Professional Corporation Act, and any present and/or future amendments thereto, and to do any act or thing necessary or convenient for the transaction of the aforementioned business and/or carrying into effect any and all of the aforesaid objects and purposes.

C. The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

#### ARTICLE III

The Corporation is to have perpetual existence.

#### ARTICLE IV

The address of the corporation's initial registered office shall be 2525 South Boulevard, Idaho Falls, County of Bonneville, State of Idaho, and the name of its initial registered agent at such address is James W. Baltzell, M.D.

#### ARTICLE V

The capital stock of the Corporation shall be one hundred (100) shares of common stock, with a par value of \$.25. The capital stock of the Corporation shall not be assessable.

#### ARTICLE VI
