


**CERTIFICATE OF INCORPORATION

That I, the undersigned, DAVE J. CAMPBELL, do hereby ~~form~~ <sup>form</sup> the following corporation pursuant to the Idaho Business Corporation Act.

**ARTICLE I**

The name of this Corporation shall be: NATIONAL HIGHTECH SERVICES, INC..

**ARTICLE II**

The period of the duration of this Corporation shall be perpetual.

**ARTICLE III**
