**KNOW ALL MEN BY THESE PRESENTS:** That we, the undersigned natural persons of lawful age and citizens of the United States, for the purpose of forming a corporation pursuant to the provisions of the Idaho Business Corporation Act (Title 30, Idaho Code) do hereby certify as follows:

## FIRST

The name of the corporation is

Precision Lettering Company Inc.

## SECOND

The corporation is to have perpetual existence.

## THIRD

The purposes and objects for which the corporation is organized include the transaction of any or all lawful business for which corporations may be incorporated under Idaho Business Corporation Act (Title 30, Idaho Code).

## FOURTH

The aggregate number of shares which the corporation shall have authority to issue is: One hundred (100). Such shares are to consist of one class only. 
