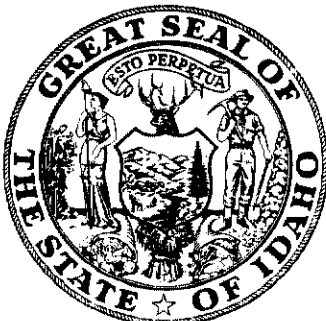

IT IS HEREBY CERTIFIED THAT:

- (1) The name of the proposed corporation is Meredith Enterprises, Incorporated.
- (2) The corporation has no period of duration, and is thus perpetual.
- (3) The purpose or purposes for which this corporation is formed, are as follows: To engage in any lawful act or activity for which corporations may be organized under the Business Corporation Law.
- (4) The office of the corporation is to be located in the County of Bonner, State of Idaho.
- (5) The aggregate number of shares which the corporation shall have the authority to issue is one hundred (100) no par.
