

ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION OF
SHOSHONE, INC.

WHEREAS, Shoshone, Inc., was duly organized under, and exists by virtue of, the laws of the State of Idaho, the same having been incorporated by the undersigned, J. Evan Robertson, as the sole incorporator; and

WHEREAS, no shares of stock in said corporation have been issued; and

WHEREAS, the undersigned incorporator has resolved to change the name of said corporation to SHOSHONE CONSTRUCTION, INC.;
