The undersigned, acting as the incorporators of a corporation under the Idaho Professional Service Corporation Act, adopt the following Articles of Incorporation for such corporation:

#### ARTICLE I

The name of the corporation is FAMILY PRACTICE ASSOCIATES, CHARTERED.

#### ARTICLE II

The period of its duration is perpetual.

### ARTICLE III

The corporation is organized for the purpose of conducting the practice of medicine and surgery. Incident to and in furtherance of the aforestated purposes, the corporation may invest its funds in real estate, mortgages, stocks, bonds, or any other type of investments, and, may own real or personal property necessary for the rendering of the aforedescribed professional services.

Consistent with the foregoing purposes of the corporation, except as prohibited by the terms of the Professional Service Corporation Act, the corporation in furtherance of its corporate purposes shall have all of the powers afforded a corporation under the provisions of the Idaho Business Corporation Act.

### ARTICLE IV

The aggregate number of shares which the corporation shall

have authority to issue is 25,000 shares of \$1.00 par value for an aggregate authorized capital of \$25,000.00.

Shares may only be issued to, held by, or transferred to a person who is licensed to practice medicine and surgery in the State of Idaho and who, unless disabled, is actively engaged in such practice.

#### ARTICLE V

There are no provisions denying or affecting the preemptive rights of a shareholder.

#### ARTICLE VI
