ARTICLE I

The name of the Corporation shall be "MEMORIES, INCORPORATED".

ARTICLE II

The Corporation's purposes are is to conduct any and all businesses or endeavors allowed under the laws of the State of Idaho for corporations for profit.

The Corporation is to have perpetual existence.

ARTICLES OF INCORPORATION - 1

ARTICLE V

The total number of shares which the Corporation is authorized to issue is 1000 shares. The aggregate par value of said shares is no par value.
