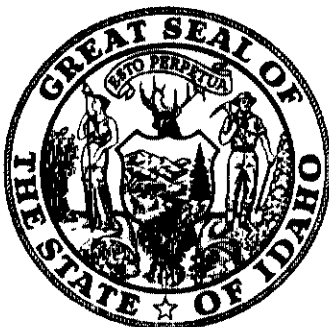
### CERTIFICATE OF INCORPORATION OF

**ARTICLES OF INCORPORATION**

of

The undersigned natural persons of lawful age, all of whom are citizens of the United States, associate ourselves and create and establish a business corporation under the laws of the State of Idaho as follows:

1. The name of the corporation is Eastover Properties, Inc.
2. This corporation shall have perpetual existence.
3. Its purpose is to own properties, real and personal, and to engage in business enterprises including the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Idaho.
4. It shall have authority to issue 20,000 shares of common stock with no par value.
5. Voting common shares have no preemptive rights.
6. The address of the corporation's initial registered office is 1609 Eastover Terrace, Boise, Idaho 83706. The name of its official registered agent at such address is Marguerite Moulton.
7. The initial board of directors shall consist of three (3) members. The number of directors may be increased by the shareholders at an annual meeting not to exceed five (5) members.
