**STATEMENT OF AMOUNTS OF ADDITIONS OF
CAPITAL STOCK OF AMERICAN BANK AND
TRUST COMPANY OF RIGBY, IDAHO,**

AMERICAN BANK AND TRUST COMPANY OF RIGBY, IDAHO,

In the State of Idaho, on being certify that on the 20th day of July, 1920, by majority vote of the Board of Directors of American Bank and Trust, Rigby, Idaho, an Idaho corporation, a meeting of the stockholders of said corporation was called to be held on the 10th day of October, 1920, at 11 o'clock, a.m., at the offices of said corporation in Rigby, Idaho, for the purpose of considering the question of increasing article Fiftieth of the Articles of Incorporation of said corporation, and, 12 thousand dollars, to meet the sum so as to increase the capital stock of said corporation to Twenty-five thousand and No/100 (\$25,000.00) dollars, divided into two hundred fifty (250) shares, at the par value of one hundred and No/100 (\$100.00) dollars each, and also for the purpose of considering the question of amending article Sixth of the Articles of Incorporation of said corporation, and, 12 thousand dollars, to meet the sum so as to provide that the number of the Board of Directors shall be three (3).

Do further certify that the notice of said meeting, and of the purpose thereof, was given, as required by the by-laws of said corporation, and as required by the law of the State of Idaho, and that the meeting of the stockholders of said corporation was duly convened and held at the offices of the corporation in Rigby, Idaho, on the 20th day of October, 1920, at 11 o'clock, a.m., of said day, and that there were present, at said meeting, shareholders of said corporation, either in person or represented by proxy, the total, as shown by the books kept of said corporation, 71 shares of the capital stock of said corporation.

"We, and we further certify that the name of the capital stock of said corporation existing at the date of said meeting was One Hundred (100) shares of the par value of One Hundred and Fifty (\$100.00) dollars each, amounting in all to One Thousand and Five Hundred (\$1,500.00) dollars.

We further certify that at said meeting, an action duly made, passed and carried by the affirmative vote of 71 shares of the capital stock of said corporation of the par value of One Hundred and Fifty (\$100.00) dollars each, and with no votes of any shares against the same, Article Sixth of the Articles of Incorporation of said corporation was amended to read as follows:

"Ninth. The name of the capital stock of said corporation shall be One Hundred Thousand and Fifty (\$100,000.00) dollars, amounting into One Hundred Fifty (150) shares of the par value of One Hundred and Fifty (\$100.00) dollars each."

We further certify that at said meeting, an action duly made, passed and carried by the affirmative vote of 71 shares of the capital stock of said corporation of the par value of One Hundred and Fifty (\$100.00) dollars each, and with no votes of any shares against the same, Article Sixth of the Articles of Incorporation of said corporation was amended to read as follows:

"Tenth. The number of members of said corporation shall be five (5)."
