

WE, THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following articles of incorporation for such corporation:

- FIRST:** The name of the corporation is PAGE ENTERPRISES INC.
- SECOND:** The period of its duration is PERPETUAL.
- THIRD:** The purpose(s) for which the corporation is organized are TO OPERATE AN INVESTMENT AND LENDING BUSINESS, AND TO OPERATE A CONSTRUCTION BUSINESS. IT IS ALSO ORGANIZED TO TRANSACT ANY LAWFUL BUSINESS FOR WHICH CORPORATIONS MAY BE INCORPORATED UNDER THIS ACT.
- FOURTH:** The aggregate number of shares which the corporation shall have authority to issue is 1000 of common stock, ONE CLASS ONLY WITH A PAR VALUE OF \$10.00 each OR OF PAR VALUE.
