

I. That the Certificate of Incorporation of the said Corporation has been amended to change the corporate title of the Corporation from "NCR FORMS INC." to "BUSINESS SYSTEMS INCORPORATED" by amending Article FIRST of the original Certificate of Incorporation to read as follows:

"FIRST. The name of the Corporation is BUSINESS SYSTEMS INCORPORATED."
