We, the undersigned, desiring to form a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the corporation is Joy Corporation.

ARTICLE TWO

DURATION

The period of the duration of this corporation is perpetual.

ARTICLE THREE

PURPOSE

The purpose of the corporation is to engage in the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
