#### ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION

of

### THE PIERCE COMMUNITY CHURCH, INC. A Religious Corporation

We, the undersigned, O. L. McCollum, president, and Roberta Gibbar, Secretary, of The Pierce Community Church, Inc., a religious corporation, hereby certify:

That at the annual meeting of said church held on Wednesday, May 13, 1970, commencing at 7:00 p.m. at The Pierce Community Church, Inc., at the southeast corner of Water Street and Stover Drive in Pierce, Clearwater County, Idaho, public notice of the intention to amend the articles of incorporation, as hereinafter set forth, having been given by publication once a week for four weeks in The Clearwater Tribune, a newspaper of general circulation printed and published at Orofino, Clearwater County, Idaho, the first publication thereof being on April 16, 1970, as will appear from the affidavit of publication attached hereto and by reference made a part hereof, and at which meeting a quorum was present, the following resolution was offered and adopted by the votes of a majority of the members of such corporation present:

BE IT RESOLVED that Article III of the articles of incorporation of this corporation, defining the purposes of the corporation, be amended by amending the lines thereof referred to as follows:

- At the end of the 4th line, delete the comma following the word "faith".
  - 2. Delete the 5th and 6th lines and the first word of the 7th

line reading "subject, however, in its government to the Rules and Discipline of the Methodist Church, under the supervision of the Pacific Northwest Conference of the Methodist Church".

- 3. Following the word "whatsoever" in line 8, delete the remainder thereof, all of line 9 and the part of line 10 reading, "subject, however, in the encumbering or disposition of the same to the Rules and Discipline of the Methodist Church".
- 4. Delete the last line following the words "by law" reading
  "or the Rules and Discipline of the Methodist Church".
  so that said Article as amended be, and the same is hereby, amended to read as follows:

## ARTICLE III (Purposes)

The purposes for which this corporation is formed are as follows:

To establish and maintain a church in the Village of Pierce, County of Clearwater, State of Idaho, and in connection therewith a suitable and customary organization for the purpose of public worship and religious training under the protestant faith; to purchase or otherwise acquire, hold, manage, sell, mortgage and otherwise encumber or dispose of real or personal property of any kind whatsoever; to receive, hold and enjoy gifts, devises and legacies; to borrow money; to execute and issue notes and bonds evidencing its indebtness and to secure indebtedness by pledge, mortgage, or other encumbrance of its property; to rent and lease real property; to do any and all things convenient and incidental to the purposes herein expressed; and generally to have and exercise all such powers as are by law conferred on corporations of like character and without in any particular limiting any of the objectives or purposes or powers of the corporation, the objectives and purposes of the corporation shall be from time to time to do any one or more or all of the acts and

things herein set forth, and all such acts, things, and business in any manner connected therewith or necessary, incidental, convenient, or auxiliary thereto or calculated, directly or indirectly, to promote the interests of the corporation or the members thereof or to enhance the value of any of its property or rights as such corporation may lawfully do; and in carrying on its objectives and purposes or for the purpose of attaining any of its objects, to do any and all things and exercise any and all other powers not prohibited by law.
