The members of this Church were notified of a public meeting to be held on January 31, 1982 for the purpose of amending the Articles of Incorporation and Constitution of the Treasure Valley Baptist Church.

The following amendments were approved by a majority vote on January 31, 1982.

The amendments are to add Article XVI to the Articles of Incorporation and the Constitution as follows:

ARTICLE XVI PURPOSE & DISSOLUTION OF INCORPORATION

Section 1. This corporation is organized exclusively for religious, charitable, literary or educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code. Section 2. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code. Section 3. Upon the dissolution of this corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to a nonprofit fund, foundation, or corporation which has established its tax exempt status under section 501(c)(3) of the Internal Revenue Code.
