Pursuant to the provisions of the Idaho Business Corporation Law, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

Article 1:

The name of the corporation shall be changed from Magic Valley Ear, Nose & Throat Associates, P.A. to Grefenson & Maxwell, Inc. The corporation shall no longer be a personal service corporation but shall be a general corporation for profit. The corporation shall no longer engage in the practice of medicine but shall do such other lawful business as the Board of Directors shall from time to time determine.

Article 2:

The number of shares of the corporation outstanding at the time of such adoption was 2; and the number of shares entitled to vote thereon was 2.

Article 3:

All outstanding shares were entitled to vote thereon and were common stock.

Article 4:

The number of shares voted for such amendment was 2; and the number of shares voted against such amendment was zero.

Article 5:

In all other respects the Articles of Incorporation are confirmed and shall not be changed or effected except as above set forth.
